SCAN OF CCSS IMPLEMENTATION TOOLS FOR STATES AND DISTRICTS

June 25, 2014

“What are resources developed specifically to measure the implementation of the Common Core State Standards across states and local educational agencies (LEAs) are available?”

The contents of this memorandum present the results of an initial scan of states, large school districts, and educational organizations for resources that have been developed for use in the measurement of standards implementation across states and LEAs. Resources include tools, surveys, rubrics, and the reports resulting from resources used to track and evaluate the implementation of standards.
